From test flights we have recently conducted when departing 16 L at VNY, we have determined that what would significantly reduce the terrible aircraft noise problems from aircraft overflying our our community, would be to revise the current VNY FAA Noise Abatement Procedures as follows: Direct all aircraft departing 16 L to CLIMB TO AN ALTITUDE of 1800' MSL PRIOR TO MAKING ANY TURNS AND BEFORE ENTERING THE DOWNWIND TRAFFIC PATTERN LEG FOR RUNWAY 16 L. All early turns resulting in climbing and simultaneously turning, while entering the downwind leg of 16 L is the source of most of the unbearable fixed wing noise where we live. In addition, reducing power to less than 70% when straight and level helps significantly alleviate the noise problem further. Lastly, revise the noise abatement instructions to direct all aircraft to fly directly over the 405 Freeway on their downwind leg.
